

Official Rules
“Trip to Radio City”
Sponsored by Pandora Jewelry, LLC (“Pandora” or “Sponsor”)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA AND HAWAII AND OUTSIDE THE 48 (48) UNITED STATES AND THE DISTRICT OF COLUMBIA, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **Entry Period:** The “Trip to Radio City Sweepstakes” (the “Sweepstakes”) commences at **10 AM** Eastern Time (ET) on **Monday, November 13th 2017** and ends at **11:59 PM** ET on **Sunday, November 19th 2017** (the “Sweepstakes Period”). Sponsor’s computer is the official time-keeping device for this Sweepstakes. All entries must be received **by 11:59 PM** ET on **November 19th, 2017**. The odds of winning depend on the total number of Eligible Entries (hereinafter defined) received for the Sweepstakes.

2. **Eligibility:** The Sweepstakes is open to individuals who are legal residents of one (1) of the 48 (48) contiguous United States (excluding Alaska and Hawaii) or District of Columbia, who are at least **twenty-one** (21) years of age or older at the time of entry. Entrants must have a public Twitter® and/or public Facebook® account in order to enter. Employees, officers, directors, and members and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) and members of their household (whether related or not) – of Pandora, Twitter Inc. (“Twitter”), Facebook (“Facebook”) and each of their respective affiliated parents, related companies, sponsors, subsidiaries, advertising, promotion, and public relations agencies, and third-party fulfillment agencies (collectively, the “Sweepstakes Entities”) are not eligible to enter this Sweepstakes.

You will receive one (1) entry for each comment and/or tweet you post. Limit: One (1) entry comment and tweet per person / account per channel. Total of two (2) entries permitted in total per person. Automated comment/tweets or comment/tweets sent via a bot will be disqualified. Comments and tweets must be publicly accessible or from an account with public settings. All entries submitted in accordance with these Official Rules shall be hereinafter referred to as “Eligible Entries”.

You will need to create a Facebook and/or Twitter account if you don’t already have one in order to enter. Registering for a Facebook and/or Twitter account is free, and registration for each channel can be obtained by the following:

By entering, you also agree that Sponsor may contact you via social media, including on Facebook or Twitter, by sending you a direct message, tagging you, posting to your social media page or naming you on Sponsor's social media page. All entries must be commented/tweeted during the Sweepstakes Period and may not be deleted or made private until after winners are selected.

Entrants must not submit entries with photographs that include third parties, including but not limited to minors, celebrities and friends, who have not expressly authorized participant to display their image or likeness or otherwise use such images or likenesses in accordance with these Official Rules. By submitting the entry, the participant represents and warrants that he/she has obtained the consent of any identifiable person other than the participant who submitted the entry who is included in the photograph submitted, and such person may be required to provide written consent to use of the entry by Sponsor and its agents.

In the event of a dispute over who submitted a winning online entry, the authorized subscriber of the Facebook and/or Twitter account used to participate in the Sweepstakes at the actual time of entry will be deemed to be the entrant. Important note: If your Facebook and/or Twitter account is set to "protected or private mode," your updates/responses may not be visible in Sponsor's @PANDORAJewelryUSA and/or @PANDORA_NA inbox. Only comments and tweets that are publicly accessible or from an account with public settings will be considered. Normal Internet access, phone, and usage charges imposed by your online or phone service may apply. If you opt to use Facebook and/or Twitter via your wireless mobile device (which may only be available via participating wireless carriers and is not required to enter the Sweepstakes), data rates may apply according to the terms and conditions of your service agreement with your wireless carrier. Other charges may apply (such as normal airtime and carrier charges) and may appear on your mobile phone bill or be deducted from your prepaid account balance. Sponsor reserves the right to disqualify any entrant who does not adequately disclose his or her participation in this Sweepstakes while engaging in any online social sharing interaction during the Sweepstakes Period.

4. **Winners Selection/Notification:** One (1) grand prize winner (the "Grand Prize Winner") and three (3) secondary prize winners (the "Secondary Prize Winners") will be randomly selected on or around **November 20th, 2017** from all Eligible Entries

received during the Sweepstakes Period. Sponsor will make one (1) attempt over the twenty-four (24) hour period following the selection of the Grand Prize Winner and Secondary Prize Winners to contact the potential Grand Prize Winner and Secondary Prize Winners via the Facebook or Twitter (depending on which channel the selected winners submitted their winning entry), via Direct Reply Message. If a potential Grand Prize Winner and/or Secondary Prize Winners does not respond with the required information within twenty-four (24) hours of being contacted, such potential Grand Prize Winner and/or Secondary Prize Winner(s) will be disqualified. If a potential Grand Prize Winner is unavailable to travel during December 15-17, 2017, or any other time period specified by Sponsor, or in the event that a potential Prize Winner is disqualified for any reason, an alternate Grand Prize Winner and/or Secondary Prize Winners, as applicable, will be selected through a random drawing from among the remaining Eligible Entries received. This process will be repeated until the potential Grand Prize Winner and the Secondary Prize Winners are verified.

5. **Winners, Verification:** The potential Winners must provide all required documentation (as detailed below) to Sponsor within three (3) days of being notified that he or she is a potential Winner and of Sponsor sending required documentation to potential Winner. In the event of non-compliance by a potential Winner, such potential Winner shall be disqualified and all privileges otherwise due as a Winner shall be terminated and an alternative potential Winner may be chosen through a random drawing from among all of the remaining Eligible Entries received. If any potential Winner is disqualified, time permitting, three (3) alternate drawings will be held for the Grand Prize and the Secondary Prize, after which any remaining prizes may remain unawarded in Sponsor's sole discretion. Within three (3) days of Sponsor sending the following documents to potential Winners, potential Winners must provide: (a) an affidavit of eligibility and liability release of the Released Parties (hereinafter defined) from any and all liability, loss, claims, demands, and causes of action for personal injury and/or damage, theft, loss, or any other harm suffered in connection with this Sweepstakes or the use/misuse or acceptance of a Prize (as hereinafter defined) or any portion thereof to be eligible for a Prize; and (b) except where prohibited by law, a publicity release granting Sweepstakes Entities the right to use his/her name and likeness for advertising and publicity purposes without additional compensation and (c) any other documentation required by Sponsor, including a W2 form and Prize Winner's social security number for tax purposes (collectively, the "Releases"). ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. AN ENTRANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL ENTRANT'S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.

6. Prizes.

- (a) **Grand Prize:** One (1) Grand Prize is available to be awarded in this Sweepstakes. **One (1) winner** will receive: a trip to New York City, New York for winner and up to three (3) guests (each, a "Guest") to attend the "Christmas Spectacular featuring the Radio City Rockettes" in New York on 12/16/17 at 2 p.m. ET, including round-trip transportation (airfare only) on 12/15/17 and 12/17/17, 2-night hotel accommodations (two standard hotel rooms), and one (1) meal voucher for three hundred U.S. dollars (\$300 USD).
- (b) **Secondary Prizes:** Three (3) Secondary Prizes will also be awarded in this Sweepstakes. Secondary Prize Winners will receive one (1) PANDORA Jewelry Rockettes exclusive holiday ornament containing (1) one new charm from the 2017 Drop 6 Collection, retail value \$85.00.

The approximate retail value ("ARV") of the Grand Prize is \$4,300 USD, the ARV for each of the Secondary Prizes is \$85. The total ARV for all prizes to be awarded in this Sweepstakes is \$4,555 USD. If for any reason any Grand Prize-related event is delayed, cancelled or postponed, Sponsor reserves the right, but is not obligated, to cancel or modify the Sweepstakes in its

discretion and shall award a substitute prize of equal or greater value. The date for fulfillment of the Grand Prize will be December 15-17, 2017, subject to change in Sponsor's sole discretion. Limit one (1) prize per person and per household.

7. **General Prize Terms:** Arrangements for fulfillment of the Grand Prize will be made by Sponsor. All costs and expenses not specifically listed as part of the Prize are solely Prize Winner's responsibility. The value of the Prize may be taxable to the Prize Winner as income. The Prize Winner may need to supply Sponsor with his/her social security numbers for tax purposes. An IRS Form 1099 may be issued in the name of the Prize Winner for the actual value of the Prize received. Upon entry into the Sweepstakes, the Prize Winner (as well as all other entrants) is required to comply with any and all applicable federal, state, and local laws, rules, and regulations. All federal, state and local taxes (if any), and any other costs and expenses associated with the Prize not specifically provided for in these Official Rules, are solely Prize Winner's responsibility. Sponsor will not replace lost or stolen Prizes.

Sponsor will determine which airport is closest to the Prize Winner's home. If Prize Winner or any Guest resides within a sixty (60) mile-radius of New York City, Sponsor reserves the right to substitute round-trip ground transportation to/from Prize Winner's and Guest's residence in lieu of air transportation. Winner and Guest must travel together. Travel subject to availability and blackout dates. Winner and Guest are responsible for obtaining all necessary travel documents. Travel arrangements must be made through Sponsor's agent and on an airline carrier of Sponsor's choice. If required, Prize Winner must be available to travel on dates specified by Sponsor or risk forfeiting prize. Certain travel restrictions may apply. Winner's travel companion must be at time of prize fulfillment the age of majority in the jurisdiction in which s/he resides (and at least eighteen (18) years of age), unless accompanied by a parent or legal guardian, and must complete and return a liability/publicity release and any other documentation required by Sponsor prior to prize award. If any Guest is a minor in his/her state of residence, minor's parent/legal guardian must complete and return all releases on behalf of minor. The passenger contracts in use by the airlines or other transportation companies shall constitute the sole contracts with respect to the Prize Winner's and his/her Guest's transportation and such contracts shall be solely between the Prize Winner, his/her Guest and such transportation companies. Lost, stolen or damaged airline tickets will not be replaced or exchanged. With the exception of stopovers approved in advance at Sponsor's sole discretion, no stopovers are permitted on tickets issued as part of the prize. If a stopover occurs, the prize travel will terminate and Prize Winner and his/her Guest will be responsible for the full fare which will be charged from the stopover point for the remaining trip segment(s), including the return. Sponsor shall not be responsible for any cancellations, delays, diversions or substitutions or any act or omissions whatsoever by any air carrier(s) or other transportation companies or any other persons providing any of these services to passengers including any results thereof such as changes in services or accommodations necessitated by same. Airline tickets issued in connection with the prize may not be eligible for frequent flyer miles or upgrades. Winner and Guest must comply with all hotel check-in requirements, including, but not limited to, the presentation of a payment card. Air transportation and hotel accommodations must be taken together and cannot be taken separately.

In the event Prize Winner or Guest engages in behavior during travel that (as determined by Sponsor) is illegal, tortious, or subjects Prize Winner or Guest to arrest or detention, Sponsor shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by Prize Winner or Guest as a result of such conduct. SPONSOR SHALL HAVE NO LIABILITY FOR

ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF ANY TRAVEL RELATED TO THE PRIZE OR ANY OTHER ASPECT OF PRIZE WINNER'S OR GUEST'S ACCEPTANCE OR USE OF THE PRIZE

If, for any reason, the Sweepstakes is not capable of running as planned, including, without limitation, unauthorized intervention, fraud, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, Sponsor reserves the right in its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, the Prizes may be awarded to Winners to be selected from among all Eligible Entries received up until and or after (if applicable) the time of modification, cancellation or termination or in a manner that is fair and equitable as determined by Sponsor. All interpretations of these Official Rules and decisions by Sponsor are final. CAUTION: ANY ATTEMPT BY ANY INDIVIDUAL TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW. Entrants agree to indemnify and hold harmless Sweepstakes Entities from any and all liability resulting or arising from the Sweepstakes, to release all rights to bring any claim, action or proceeding against Sweepstakes Entities.

EACH ENTRANT WAIVES ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THESE COURTS AND HEREBY SUBMITS TO THE JURISDICTION OF THOSE COURTS. Except where prohibited, as a condition of participating in this Sweepstakes, each entrant agrees that any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, the Prizes awarded, or the determination of the Official Winner shall be resolved individually, without resort to any form of class action.
